The Public Policy Committee works tirelessly for HABA. Here are a few updates:

The Public Policy Sub-committee meets on a monthly basis and the group has made the commitment to provide a summary of topics discussed to members following the meeting. Welcome to our first monthly summary.

 2019 CPT Codes: The new Category I ABA therapy procedure codes are effective for ABA services. Payors have been providing guidance regarding their specific transition to the use of the new codes. Medicaid recently released its bulletin (BT201866; BT 201867) providing direction for professionals billing ABA services.

- ABA Workgroup: This is a state-wide meeting that includes representation from multiple provider groups, educators, university representatives and policy makers. The goal of the group is to allow communication on topics that are relevant to ABA services with the goal of improving service delivery for children and adults receiving ABA treatment through education and communication. The group has recently reformed and HABA has been invited to continue participation in the group. The first meeting will be in February 1, 2019.
- BACB transition of VCS: Starting in 2019 the BACB will transition oversight of the Verified Course Sequence for academic programs to ABAI.
